ORDINANCE NO. 13-02

AN ORDINANCE AMENDING ORDINANCE 1-02

WHEREAS, the Board of Directors of the Bass Lake Conservancy District originally adopted Ordinance 1-02, establishing a Porta-Potty Ordinance;

WHEREAS, the Board of Directors has reviewed the existing standards of the Porta-Potty Ordinance;

WHEREAS, the Board of Directors of the Bass Lake Conservancy District upon review of the Porta-Potty Ordinance does desire to amend the existing Porta-Potty Ordinance;

WHEREFORE, IT IS HEREBY ORDAINED BY the Board of Directors of the Bass Lake Conservancy District to amend the Porta-Potty Ordinance 1-02 to state the following:

BE IT RESOLVED BY the Board of Directors of the Bass Lake Conservancy District as follows:

The Board of Directors of the Bass Lake Conservancy District concludes that any Property Owner, Person, or Entity within the Bass Lake Conservancy District, must obtain the permission of the Bass Lake Conservancy District for the placement of a Porta-Potty within the District's territory.

The Property Owner, Person or Entity shall submit their request in writing for the placement of the Porta-Potty, the number necessary, the time duration needed, and rational for such to the Bass Lake Conservancy District.

Should the time duration requested be less than thirty (30) days, the Bass Lake Conservancy District Executive Director shall, upon a proper showing, grant permission to the Owner, Person or Entity for Porta-Potty usage.

Should the time duration requested be greater than thirty (30) days, the permit shall come before the Board of the Bass Lake Conservancy District for review and permission. The Board may request the Owner, Person or Entity's representative to come before the Board to discuss the usage requested.

Should a Porta-Potty be placed within the jurisdiction of the District without prior permission being granted by the Board, a fine of \$100 may be assessed, plus \$25 for each day thereafter, with each day of non-compliance being considered a separate offense.

Each Porta-Potty shall be securely anchored in a manner so as to prevent it from being tipped or moved. Failure to properly secure such Porta-Potty shall result in a fine of \$100, plus \$25 for each day thereafter, with each day of non-compliance being considered a separate offense. Should the failure to secure result in spillage into the Bass Lake waterway, a separate, reasonable cleanup fee shall be assessed.

ALL OF THE TERMS, PROVISIONS, AND CONDITIONS of the remainder of Ordinance 1-02 shall remain in full force and effect as originally adopted and until further amended or modified by the Board of Directors of the Bass Lake Conservancy District.
