

**BASS LAKE CONSERVANCY DISTRICT
ORDINANCE NO. 02-1**

**AN ORDINANCE AMENDING ORDINANCE 96-1
REGULATING THE CONNECTION TO AND USE OF
PUBLIC AND PRIVATE SEWERS AND DRAINS, THE
INSTALLATION AND CONNECTION OF BUILDING
SEWERS, AND THE DISCHARGE OF WATERS AND WASTES
INTO THE PUBLIC SEWER SYSTEM OF THE
BASS LAKE CONSERVANCY DISTRICT, AND PROVIDING
PENALTIES FOR VIOLATIONS THEREOF**

WHEREAS, the Board of Directors of the Bass Lake Conservancy District adopted Sanitary Sewer Use Ordinance 96-1 on the 8th day of June, 1996; and

WHEREAS, the Board of Directors of the Bass Lake Conservancy District has deemed it necessary to adopt certain amendments to the aforementioned ordinance as it relates to Section 17 regarding violations of the aforementioned ordinance and concerning penalties for violations thereof.

THEREFORE, IT IS HEREBY ORDAINED by the Board of Directors of the Bass Lake Conservancy District that Section 17 of Ordinance 96-1 should be and the same is hereby amended to read as follows:


Section 17:

- (a) Any person found to be violating any provisions of this ordinance and/or any other rule, regulations or specification adopted by the Board of Directors of the District, shall be served by the District with written notice stating the nature of the violation and providing a reasonable time limit for the satisfactory correction thereof. The offender shall, within the period of time stated in such notice, permanently cease all violations.
- (b) Any person who shall continue any violations beyond the time limit provided in Section 17 (a) shall be guilty of a violation and shall be fined in an amount not exceeding Two Thousand Five Hundred Dollars (\$2,500.00) for each violation. Each day in which any violation shall continue shall be deemed a separate offense. Any person violating any of the provisions of this ordinance and/or any rule, regulation or specification adopted by the Board of Directors of the Conservancy District shall become liable to the District for any expense loss or damage occasioned by the District by reason of such violation.
- (c) Notwithstanding subpart (a) and not intending to limit the authority of the Board of Directors, the following prescribed activities shall result in the immediate imposition of the noted fines:


- (i) Attempting to connect/hook-up and/or cutting into the District's Sewer System without having a District Inspector present - Two Thousand Dollars (\$2,000.00) plus actual costs of repair;
- (ii) Damaging the District's Sewer System or property and not reporting such damage to the District's Inspector or a Member of the Board of Directors within twenty-four (24) hours of such incident - Two Thousand Dollars (\$2,000.00);
- (iii) Working without insurance during the connecting of the District's Sewer System to a user - One Thousand Five Hundred Dollars (\$1,500.00) plus such contractor shall immediately terminate all work until valid proof of insurance information is presented to the District Inspector. Should a particular contractor be cited for this offense in excess of three (3) times within one calendar year, the contractor will lose its right to do any work relating to the District's Sewer System;
- (iv) Failure of a Property Owner to connect a new home to the District's Sewer System within Sixty (60) days of completion - One Thousand Five Hundred Dollars (\$1,500.00);
- (v) Scheduling an inspection by the District Inspector and failing to be present at the scheduled time - One Hundred Dollars (\$100.00);
- (vi) Pumping ground water into District's Sewer System - One Thousand Five Hundred Dollars (\$1,500.00);
- (vii) Cutting into the District's Sewer Line and damaging the integrity of the Sewer System - Two Thousand Dollars (\$2,000.00) plus actual costs of repair;
- (viii) Concerning grease traps, should the District Inspector discover unreasonable build-up attributable to the Property Owner - One Thousand Dollars (\$1,000.00) first offense, One Thousand Five Hundred Dollars (\$1,500.00) second offense, Two Thousand Dollars (\$2,000.00) third offense.


